Labor backs Catholic schools boost

- Catholic schools have won a \$362 million boost under a federal funding overhaul in which they will be paid in the same way as other non-government schools.
- Prime Minister John Howard, announcing the funding increase yesterday in Sydney with Catholic Archbishop George Pell, said the extra money would go to the neediest schools.


